Parish Council Meeting held on the 9th January 2024 at Eamont Bridge Village Hall

123/145 Apologies Penrith Town Council D. Smith

123/146 Declaration of Interest

Resolved it be noted that no member declared any interests in any item on the agenda

123/147 Minutes of the meeting held on the 14th November to be confirmed as a true record and signed by the chairman.

123/148 Road Closure -U 3166 from B5320

Repairs were due to start on the 30th November on the junction on the B5320 and U3166 road. The work had to be delayed until the 4th December. There had been constant flooding at the junction this has now been resolved.

123/149 Application for the speed limit to be reduced to 30mh on the B5320 road at Yanwath

The Clerk reported she had registered the request from the Parish Council to reduce the speed limit from 40mph to 30 mph on the B5320 road at Yanwath. This has been accepted. Enquiry number 41/176760.

123/150 Application Form Speed Limit to be reduced to 20mph

The Parish Council discussed whether to complete the 20mph forms for a reduction to 20mph at Yanwath. Councillor Battersby proposed that due to the parish council applying to have the speed limit reduced from 40mph to 30mph this is more likely to be agreed than 40mph to 20mph. The Parish Council should wait until the B5320 road at Yanwath is reduced to 30mph, then start the procedure to have the road reduced to 20mph. Councillor Murray seconded the proposal. All the parish councillors agreed to the proposal.

123/151 Common Land Yanwath

An e mail has been received by the parish council from parishioners at Glendowlin, the parishioners also attended the meeting they are requesting they and other parishioners of Glendowlin be able to walk their dogs onto the common land. Open discussion then took place. There were concerns there could be a dog fouling problem especially as children use the common play area. It was suggested that a new dog bin could be purchased and erected on the gate to the common land. It would be hoped that dog owners respect other users of the land. Discussion then took place over the state of part of the common land. Councillor Battersby proposed a meeting be arranged with Councillor Brookes, Mr and Mrs Pyrah and himself at the common land to access what work needs to be done. A skip will have to be hired to remove all the rubbish. Mr and Mrs Pyrah have volunteered to help with getting the area cleared. Councillor Hughes suggested there maybe a grant available from the Westmorland and Furness Council.

Councillor Battersby reported he has now received 100 trees ready for planting at the common land.

Westmorland and Furness forwarded an e-mail .A delay in payment of the recycling credit to the Parish Council from Westmorland and Furness council is due to the finance department having problems due to the recent merger of the councils.
